The Master of Arts in College Student Development and Administration provides a combination of coursework and practical experiences that prepares students for careers in student affairs and other student services at both two- and four-year institutions. Shepherd University's intimate size provides unique small school experiences for students in the CSDA program. With many institutions around the country and world similar in size to Shepherd, this program provides a distinct advantage for the student who wishes to work in a small school setting.

The Master of Arts in College Student Development and Administration is a 36-credit hour program for those who have completed a bachelor's degree and are interested in pursuing or advancing a career in student affairs or enrollment management.

The CSDA program, working cooperatively with various departments on campus, has committed to the practical experience of full-time students by currently offering graduate assistantships in Academic Advising, Career Services, Community Service and Service Learning, Student Conduct, Disability Support Services, Fraternity and Sorority Life, Multicultural Student Affairs, Residence Life, Student Activities and Leadership, Student Union, and TRiO Student Support Services. ■ Honor Societies and Professional Activities

CSDA students with requisite graduate school GPAs and other requirements are eligible for Phi Kappa Phi Honor Society and Chi Sigma Alpha Student Affairs Honor Society.

Shepherd CSDA students have been selected to participate in internships, elected to offices, and presented programs at the following national and regional associations: ACPA-College Student Educators International, NASPA-Student Affairs Administrators in Higher Education, Association of College Unions International, National Association for Campus Activities, and Mid-Atlantic Association of College and University Housing Officers.

Many students opt for a study abroad experience to enhance their master's experience. Study abroad can serve as an elective in the program if pre-approved by the program coordinator.

Required courses, 30 Hours:

■ Admission Requirements

- Entrants must have completed a bachelor's degree with a 2.75 GPA in all undergraduate coursework.
- CSDA students must complete one essay question: What do you hope to do with a master's in College Student Development and Administration? (Max 500 words)
- Writing sample: 5-7 pages of a previously written research paper OR submit a 5-7 page research paper discussing a current trend in higher education.
- Reference letter from a faculty member answering the question: How is this student prepared for the rigor of graduate school, specifically addressing oral and written communication skills? (Optional)
- Students who do not meet all of the requirements may be considered for conditional admission.

Deadlines:

February 15: For fall applicants seeking to participate in assistantship interview process.

July 31: For fall applicants.

November 15: For spring applicants.
