"Page 52 of the current catalog will be revised as follows regarding the "course sharing" policy:

- 1. Item 3 will be revised as 'A student cannot select a minor field of study whose required courses duplicate the major field requirements by more than 2 courses, up to 8 semester hours. Exceptions to this rule must be approved by the vice president for academic affairs.'
- 2. Item 4 will be deleted so that students will no longer need to find course substitutions for courses required in both major and minor programs."
