CLASSIFIED EMPLOYEES COUNCIL MINUTES NOVEMBER 21, 2016

Chair Brian Hammond called the meeting to order at 9:00 a.m. and asked for a motion to approve the Classified Employees Council Meeting Minutes from October 18, 2016. It was MSP to approve the minutes as presented.

Brian Hammond suspended the meeting agenda to introduce President Hendrix.

President Hendrix remarked on two concerns:

- The 2% budget cut imposed by the state will amount to about \$190,000 for Shepherd. However, the bond refinance being pursued by the University will save about \$250,000 - \$300,000, which will offset the 2% budget cut.
 She hopes that the state hiring freeze will not affect higher education.
- The University officially petitioned Governor Tomblin to allow Shepherd to re-address PEIA, asking him if it would be a possibility for us to use an independent insurance company to provide our health insurance. He refused to address that issue.

President Hendrix asked for questions from the council:

Marie: When will we know if higher education is going to be affected by the state hiring freeze? **President Hendrix:** Will check with Ed Magee at HEPC.

The hiring freeze, if higher education is included, would take effect January 1, 2017.

REPORTS

ACCE (Advisory Council of Classified Employees): Ken Harbaugh

ACCE met at Glenville last Wednesday.

Layoffs/furloughs: ACCE is disappointed that HEPC is not responding to requests to further define and implement policies related to these two options available to address the economic needs of the state.

Mercer and the HEPC do not seem to be working together on the employee classification project.

The Mercer market study showed the areas and dollar amounts it is going to take Shepherd to bring employees up to market levels.

Ken handed out the HEPC report, "2015 Human Resources Report Card." The full report can be found on the HEPC website under "meetings." It gives a lot of detailed information on HR statistics for the individual Higher Education institutions. Highlights:

- PEIA: Details the devastating effects of the poor financial situation faced by PEIA
- Layoffs and furloughs: State code treats layoffs and furloughs the same way when they are two
 very different situations. ACCE has been asking for two years for a furlough rule to be
 developed by HEPC so that, if it is necessary, all state institutions will be prepared.
- New personnel administration system (Mercer Project): ACCE is asking for progress to be made
 on implementation of a new personnel administration system. Many employees feel the delays
 and lack of progress are just one more effort to let another Legislative session pass without
 moving forward.
- Committee work, "things we could be doing:" Progress on issues like: employment practices, a study on human resource information system, and completion of best practices manual, could move forward through work by committees.

ACCE meets next on December 7, 2016. We will be presenting to the Community College Council on December 8.

Board of Governors: Ramona Kissel

The Board of Governors met last Wednesday. The minutes are on the website. Mona, absent from today's meeting, will give her notes to the council in January. Gat Caperton was sworn in as a new Board member.

Ken: Noted (from BOG Agenda Book for Nov. 16 meeting) the Shepherd student faculty ratio is now about 15.5:1.
